Sub: TSFD – F(C) Act, 1980 – Renovation / Laying of underground Raw water pipeline besides the existing pipeline within the forest and allotted to M/s. ITC from Iravendi Village to ITC, Bhadrachalam Paper Boards Ltd., Sarapaka to an extent of **4.2768 Ha** falling in Manuguru Division of Bhadradi Kothagudem District in favour of M/s. ITC Limited – **In - principle (Stage-I) approval – Accorded** - Demand Notice issued – Reg.

It is to inform that, the IRO, MoEF & CC, Government of India, Hyderabad vide reference 1st cited has accorded in-principle (Stage - I) approval for Renovation / Laying of underground Raw water pipeline besides the existing pipeline within the forest and allotted to M/s. ITC from Iravendi Village to ITC, Bhadrachalam Paper Boards Ltd., Sarapaka to an extent of **4.2768 Ha** falling in Manuguru Division of Bhadradi Kothagudem District in favour of M/s. ITC Limited subject to certain conditions stipulated therein and the same was communicated by the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad vide reference 2nd cited and issued instructions to raise demand note as per actual rates and issue demand note to the User agency only after vetting of the same by the concerned Conservator of Forests, who in-turn has to upload the demand online on Ministry's portal, generate challan & transfer funds through online only into Ad-hoc CAMPA accounts of Telangana.

Further, the Principal Chief Conservator of Forests (HoFF), TS, Hyderabad issued instructions that, the charges for felling, logging, transportation of project affected trees & the funds towards expenditure like boundary walls, stone pillars, demarcation charges etc., should be deposited with the Divisional Forest Officers concerned and the work should be undertaken departmentally in-order to ensure that the task of felling / transportation / stone pillars etc., are

undertaken faithfully and in the best interests of the forest. The funds deposited with the DFOs for carrying out such activities should be put to actual utilization only on the grant of 2nd Stage (final) clearance and / or working permission, whichever is earlier and clarification issued by the Ad-hoc CAMPA Wing vide F.No.13-20/2015-CAMPA, dt.09.06.2016 in this regard.

Further, the Scheme proposals for Extraction charges of Mango trees in Non-Forest land identified in Sy.No.440/18,19 &20 and Planting forestry species in the gaps created due to removal of alternate rows of existing mango trees as per condition No.4 (d) was submitted to the Chief Conservator of Forests, Bhadradi Circle, Warangal vide this office reference 6th cited for approval and demand notice was prepared including financial layout of **Rs. 18.95597 Lakhs** of above scheme, accordingly the Chief Conservator of Forests, Bhadradi Circle, Warangal has approved the above scheme vide reference 8th cited.

In this connection, it is inform that, as per the above said instructions of the Principal Chief Conservator of Forests (HoFF), TS, Hyderabad, the Forest Divisional Officers, Manuguru and Paloncha vide references 4th and 5th cited have submitted the following demand notice for approval and the same was submitted to the Chief Conservator of Forests, Bhadradi Circle, Warangal vide this office reference 7th cited for approval and the same was approved by the Chief Conservator of Forests, Bhadradi Circle, Warangal vide reference 9th cited.

Hence, the following demand notice is hereby issued to the User agency.

Manuguru Division:

1. The User Agency has to deposit an amount of **Rs. 40.96234 Lakhs** (Rupees Forty lakhs ninety six thousand two hundred and thirty four only) and to upload the demand through online on Ministry's portal by generating challan & transfer the funds through online only into Ad-hoc CAMPA accounts of Telangana.
2. The User Agency has to deposit an amount of **Rs.2.29000 Lakhs** (Rupees Two lakhs Twenty nine Thousand only) into the above said PD Account of Forest Divisional Officer, Manuguru.

Paloncha Division:

1. The User Agency has to deposit an amount of **Rs. 131.20737 Lakhs** (Rupees One Crore thirty one lakhs twenty thousand seven hundred and thirty seven only) and to upload the demand through online on Ministry's portal by generating challan & transfer the funds through online only into Ad-hoc CAMPA accounts of Telangana.
2. The User Agency has to deposit an amount of **Rs. 8.08541 Lakhs** (Rupees Eight lakhs eight thousand five hundred and forty one only) into the above said PD Account of Forest Divisional Officer, Paloncha.

The User agency is requested to make the payment against the demand notice raised and furnish the details of payment along with the UTR number, date, and amount transferred etc., to Forest Divisional Officers, Paloncha and Manuguru and to this office at the earliest.

Further, the User Agency is also requested to comply with the following in accordance with the MoEF&CC, GoI instructions issued vide F.No.7-23-2012-FC, dt.24.07.2013 communicated vide Prl.Chief Conservator of Forests (HoFF) Hyderabad Rc.No.45921/2001/F4, dt.23.08.2013:

1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central Government in two widely circulated daily newspaper one in vernacular language and the other in English granted to the Project proponent for the use of forest land for the non-forest purposes.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.

Further the User Agency is requested to furnish the condition wise compliance report along with undertakings and documents as per the conditions stipulated in the Stage-I (in-principle) approval immediately for obtaining the Stage-II (final) approval.

Further the User Agency is requested to take up and complete the Construction of Chain link fencing (1.152 km) around the CA Non forest land at the cost of the User agency and report compliance.

Further, the User Agency is requested that, the transfer of forest land to User Agency shall not be affected prior to the issue of the grant of 2nd Stage (final) clearance and / or working permission, whichever is earlier and no work in violation shall be carried out.
