In inviting a kind reference to the above cited memo number on the captioned subject and in view of the instruction issued by the Conservator of Forests (Nodal), O/o. the Principal Chief Conservator of Forests, Odisha in his memo No.24853 dated.09.12.2024, you are requested to deposit an amount of **Rs. 2,55,87,200/-** (Rupees Two Crore Fifty Five lakh Eighty Seven thousand Two hundred) only towards C.A. scheme cost over an area of 33.152 Ha. of Non-forest land identified in village Kaliaguda, Kanipai and Berlang under K.Singpur Tahasil & in village Dambalu under Muniguda Tahasil of Rayagada District/Division and an amount of **Rs. 2,51,33,300/-** (Rupees Two Crore Fifty One Lakh Thirty Three Thousand Three Hundred) only towards A.C.A. scheme cost over an area of 42.50 Ha. of Degraded forest land identified in Mirabali RF(20.00 ha.) and Kutuli RF(22.50 ha.) under Rayagada Range of Rayagada District/Division through online web portal of MoEF & CC and submit the deposit particulars of the amount paid in the prescribed CAMPA format to this office for taking further action at this end.


