I enclose herewith a copy of the letter cited along with statutory proforma proposal under Forest (Conservation) Act, 1980, submitted by the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh for diversion of 5.92 ha of forest land in compartment No.1231, 1232 & 1236 of Dharakonda and Dharakonda Extn. RFs, Narsipatnam Division for formation and BT to the road including construction of culverts from Yerrabanda to Sarabannapalem in favour of Executive Engineer, Panchayat Raj (PIU) Division, Visakhapatnam.

2. I am to inform that the User Agency i.e. Executive Engineer, Panchayat Raj (PIU) Division, Visakhapatnam, has furnished justification stating that the buses and commercial vehicles are not plying on this road due to improper geometry and various streams crossing the road. The people are facing lot of problems to meet their needs of education, health and transportation of agricultural and forest produces etc. Hence, the road is proposed to upgrade to BT standard so as to make the road traffic worthy. The requirement of forest land is un-avoidable and barest minimum for the project. The User Agency has identified non-forest land over an extent of 5.920 ha in Sy.No.418-P of Kommika (V), Koyyuru Mandal, Visakhapatnam District for CA purpose. The User Agency has furnished undertakings for payment of NPV, Addl. NPV, CA and tree extraction charges etc. The District Collector, Visakhapatnam District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The proposal has been uploaded in the Ministry's website and unique file No.FP/AP/ROAD/37597/2018 has been generated for this proposal. The concerned Divisional Forest Officer, the Chief Conservator of Forests and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in proforma proposal in Part-V is enclosed herewith.

3. I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under Section-2 of Forest (Conservation) Act, 1980, for diversion of 5.92 ha of forest land in compartment Nos.1231, 1232 & 1236 of Dharakonda and Dharakonda Extn. RFs, Narsipatnam Division for formation and BT to the road including construction of culverts from Yerrabanda to Sarabannapalem in favour of Executive Engineer, Panchayat Raj (PIU) Division, Visakhapatnam, at an early date.
