Sub: Diversion of 2.65 ha of forest land in Compartment No.860 of Sankaram RL and Compartment No.861, 862 & 808 of Madugula Beat, Visakhapatnam Division for formation of road from Paderu Waddadi R&B road to Konam via Poolabanda (PV R&B road at 12 mile to Devapuram) in favour of Executive Engineer, PR (PIU) Division, Paderu - Proposal submitted under section 2 of F(Conservation) Act, 1980 - Reg.

I enclose herewith a copy of the letter cited along with statutory proforma proposal under Forest (Conservation) Act, 1980, submitted by the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh for diversion of 2.65 ha of forest land in Compartment No.860 of Sankaram RL and Compartment No.861, 862 & 808 of Madugula Beat, Visakhapatnam Division for formation of road from Paderu Waddadi R&B road to Konam via Poolabanda (PV R&B road at 12 mile to Devapuram) in favour of Executive Engineer, PR (PIU) Division, Paderu.

2. I am to inform that the User Agency i.e. Executive Engineer, PR (PIU) Division, Paderu, has furnished justification stating that the villagers of 12th mile, Isakgarauvu, Poolabana, Kakki, Edulapalem, Pulusumamidi & Devapuram reach the mandal head quarters Paderu with shortest path by providing this road, the proposed road passes through Reserve Forest in various reaches in the road from 0/0 to 14/000 km. This is the only the shortest route for the people of the above habitations. The buses and commercial vehicles are not plying on this road due to improper geometry and various streams crossing the road. The people are facing lot of problems to meet their needs of Education, Health and Transportation of Agricultural and forest produces etc. The requirement of forest land is unavoidable and barest minimum for the project. The User Agency has identified non-forest land over an extent of 2.650 ha in Sy.No.418-P of Kommika (V), Koyyuru Mandal, Visakhapatnam District for CA purpose. The User Agency has furnished undertakings for payment of NPV, Addl. NPV, CA and tree extraction charges etc. The District Collector, Visakhapatnam District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The proposal has been uploaded in the Ministry's website and unique file No._FP/AP/ROAD/59874/2020 has been generated for this proposal. The concerned District Forest Officer, the Chief Conservator of Forests and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in proforma proposal in Part-V is enclosed herewith.

I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under Section-2 of Forest (Conservation) Act, 1980, for diversion of 2.65 ha of forest land in Compartment No.860 of Sankaram RL and Compartment No.861, 862 & 808 of Madugula Beat, Visakhapatnam Division for formation of road from Paderu Waddadi R&B road to Konam via Poolabanda (PV R&B road at 12 mile to Devapuram) in favour of Executive Engineer, PR (PIU) Division, Paderu, at an early date.
