- 3. Deputy Conservator of Forests has certified that-
 - Forest land required for the project is barest minimum

- Felling of 979 trees involved in the project.
- There is no violation of Forest (Conservation) Act, 1980.
- Proposed project is not likely to affect any monumental site of cultural, historical, religious, archaeological or recreational importance.
- Proposed forest land is not a part of National Park, Sanctuary or Nature Reserve
- Proposed land is at distance 1.475 km from Tansa Wildlife Sanctuary and within deemed Eco-Sensitive Zone.
- Compensatory Afforestation is proposed over 5.00 ha. degraded forest land of Protected Forest land in Survey No. 99, Gut No.156 at Village Shei, Tal. Shahapur, Dist. Thane and it is suitable for afforestation.
- Three alternatives have been examined and Alternate-I has been selected.
- 4. The User Agency has submitted undertakings to defray the cost of Net Present Value and Compensatory Afforestation.
- 5. The Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur has recommended the proposal subject to the conditions, given in his specific recommendations, under Section-2 (ii) of the Forest (Conservation) Act, 1980. His specific recommendations are enclosed in the proposal.
- 6. In the circumstances explained in aforesaid paragraphs and enclosures, the State Government recommends that the said forest land may be allowed to be diverted subject to the conditions proposed by the Principal Chief Conservator of Forests (HoFF), Maharashtra State, Nagpur in addition to following conditions:-
- a) Deputy Conservator of Forests shall ensure the legal status of the proposed land and it attracts the provisions of Forest (Conservation) Act, 1980, before granting working permission.
 b) User Agency shall compensate private land holders as per relevant Acts and Guidelines.
 c) As some Shrubs are present over the land proposed for Compensatory Afforestation, if forest department is unable to plant 1000 trees/ha, remaining plantation shall be carried on degraded forest land. Details of such degraded forest land shall be submitted to the State Government and IRO, MoEF&CC, Nagpur.
 d) User Agency shall obtain Wildlife Clearance / comply with mitigation measures, if required.
 e) Proposed Forest land shall be reclaimed after work.

The matter may kindly be placed before the Government of India for approval under Section-2 (ii) of the Forest (Conservation) Act, 1980.
