With reference to the subject cited above on the captioned subject, it is intimate you that the financial out lay for Dwarf Plantation Scheme over a length of 6.045 KM. Pertaining to the above project amounting to Rs.44,01,987/- (Rupees Forty four Lakhs One Thousand Nine Hundred Eighty Seven) only has been technically approved by RCCF Rourkela at the wage rate of Rs.308/- per man days with 10 years maintenance. This fund was deposited by you vide UTR No. SBINR 52020122403492887 dt.24.12.2020 & A/c No. 150826438533584 through RTG.

Due to revision of wage rate Rs.308/- MD to Rs.315/- MD the above financial outlay of Dwarf Plantation Scheme technically approved by the RCCF, Rourkela vide his memo under reference of Rs.52,74,000/- (Rupees Fifty Two Lakhs Seventy Four Thousand) only.

Therefore, you are requested to deposit the differential amount of (Rs.52,74,000.00 – Rs.44,01,987.00) = Rs.8,72,013/- (Rupees Eight Lakhs Seventy Two Thousand Thirteen) only as the differential amount towards the Dwarf Plantation Scheme for payment through web portal (<http://parivesh.nic.in>) of MoEF & CC and submit the deposit particulars to this office at early date for taking necessary action at this end.
