With reference to Memo no. on the subject cited above, the **Compensatory Afforestation** Scheme over **17.0 ha** of degraded forest land identified in Kukia RF has been revised and technically approved by the PCCF (Forest Diversion and Nodal Officer, FC act) at the current wage rate **Rs.333/-** per mandays with financial out lay of **Rs.18,39,700 /-** (Rupees Eighteen Lakh Thirty Nine Thousand Seven Hundred only). Previously financial out lay of Compensatory Afforestation Scheme was **Rs.14,38,800 /-** (Rupees Fourteen Lakh Thirty Eight Thousand Eight Hundred only). So, you are requested to deposit the differential amount of **Rs.4,00,900 /-(18,39,700 - 14,38,800)** (Rupees Four Lakh Nine Hundred only) in the **State Specific CAMPA Account** maintained by Govt. of India through "E" payment mode by using the web portal of Ministry of Environment & Forests (CAMPA).
