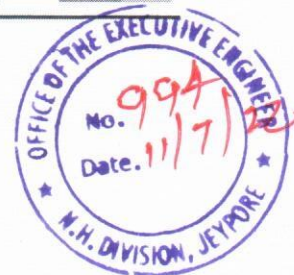

Sub: - Diversion of 10.635 ha of Forest Land for the work "Widening to two lane form 327/700 to 413/700 Km of N.H. 326 (erstwhile Km from 16/0 to 102/0 Km of SH-25) under Vijayawada-Ranchi route in Koraput and Malkangiri District of Odisha on EPC basis"- Revision of CA Scheme-regarding.

Sir,

With reference to this office letters on the captioned subject cited above, it is to inform you that you have already deposited the Compensatory Afforestation Scheme amount of Rs. 5454700/- (Rupees Fifty four lakh fifty four thousand seven hundred) only through e-portal in the old wage rate @ Rs.315/-. In the mean while Govt. has enhanced the wage rate @ Rs.326/MD w.e.f. as per Notification No.2433 dated 30.04.2022 of the Labour Commissioner, Odisha. Now, the revised Compensatory Afforestation amount comes for Rs. 6018400/- as per wage rate of 326/MD with provision of planting of 18 months seedlings. A copy of Technically Approved Compensatory Afforestation Scheme by the Chief Conservator of Forests, Forest Diversion & Nodal Officer, FC Act is enclosed herewith for your reference.

You are, therefore, requested to make the balance Compensatory Afforestation amount of Rs. 563700/- i.e. (Rs. 6018400 - Rs. 5454700= Rs. 563700/-) through e-portal immediately and report the fact of deposit to the undersigned for taking further action at this end.

In continuation to this office memo on the subject cited above, it is to inform you that the revised financial outlay for Compensatory Afforestation Scheme over an area of 10.785 ha of Revenue Forest land identified in Rekhapali village of your division pertaining to the above project has been approved by CCF (FD & Nodal Officer, FC Act) at prevailing wage rate of Rs.326/- per manday amounting to Rs 60,18,400/- (Rupees sixty lakhs eighteen thousand and four hundred) only.

1. The financial outlay of the CA Scheme was earlier approved for Rs.54,54,700/- at the then wage rate of Rs.315/- per manday which has already been paid by the user agency. The differential cost of CA to the tune of Rs 5,63,700/- (Rs 60,18,400 - Rs 54,54,700) needs to be demanded to the user agency for payment of the same in CA Head.
2. The approved financial outlay for CA Scheme is enclosed herewith for information and necessary action.

You are requested to raise demand on the user agency for payment of the differential amount through web portal of MoEF & CC and submit the deposit particulars of the amount paid. Further, you are also requested to furnish the statement of funds towards compensatory levies deposited by the user agency in the prescribed CAMPA format duly signed by you alongwith the updated Stage-I compliance.




