With reference to the above cited subject, Government of India vide Ref(1) have accorded Stage-I approval under the Forest (Conservation) Act, 1980 for the above proposal subject to certain conditions. As per condition No.(3), the User Agency has to remit the Compensatory Afforestation Charges and also as per condition No.(5) SMC Charges within 200 mtrs. of road from time to time.

However, the Compensatory Afforestation charges have been revised vide Ref(3) and the same was intimated to your office for payment of the same vide Ref(4). Further on verification of the online payment made by the User
