

SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF
(for the forest land to be diverted under FCA)

5.1 A proposal has been received by this office from P.M.G.S.Y.I.D. Purola for diversion under FCA-1980) of 4.950ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of Construction of Begal Motor Road from Km.3.00 of Mhandarth-Bhankwar Motor Road in Block Mori District Uttarkashi, Under P.M.G.S.Y. The site inspection of the land involved in the proposal has been done by me on dated 07/11/2015.

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 4.950ha.

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project.
