

SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF

5.1 A proposal has been received by this office from **R.E.S. P.I.U P.M.G.S.Y. Didihat** for diversion under FCA-1980) of **6.1395** ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **Birtola-Belkot Motor Road km 9.000**. The site inspection of the land involved in the proposal has been done by me on dated...1-7-2014.

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/protected forests measuring **6.1395** ha.
