SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF

5.1 A proposal has been received by this office from Construction Division, P.W.D. Purola for diversion under FCA-1980) of 1.034 ha. (For Muc disposal 0.150ha in RF and 0.245 ha in R.Land Total 0.395 ha required for Muc disposal) Total 1.429 ha of forest land for non-forestry purpose. The project envisages the use of forest land for construction of Construction of Hudoli to Bingadera Malla Motor Road in Block purola District Uttarkashi, Under CM Ghosna No. 237/2013. The site inspection of the land involved in the proposal has been done by me on dated 11/2/2015

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 2.34 ha.

5.3 The requirement of forest land as proposed by the user agency in Col.2 part-1 is unavoidable and is barest minimum required for the project.
