Diversion of **1.7329 ha.** Protected forest land for laying 90MM/125MM Dia. MDPE Gas Pipeline Along/Across Rampura, Fulgram, Madhadnana, Malod, Timba, Waghela, Dudhrej, Chamaraj, Adheli, Nagra, Khodu, Baldana and Valod Ta. **Wadhwan** (Area **1.7329 ha.**). The Width of trench to be dug @0.60meter across road. The site inspection of the land involved in the proposal has been done by me on

MDPE Gas Pipeline Along/Across Devalia Connectivity, Jamar Connectivity to SH-38 Limbdi-Siyani-Lakhtar Road and SH-17-Wadhwan-Viramgam Road Ta. **Lakhtar.** (Area **0.2111 ha.**). (SH-119) Ta. **Chotila.** (Area **0.0393 ha.**). The Width of trench to be dug @0.60meter across road. The site inspection of the land involved in the proposal has been done by me on

On inspection of the site it is found that the land required by the user agency is a Protected Forest admeasuring **0.0393 ha** in Ta. **Chotila.**
