

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

A proposal has been received by this office from Executive Engineer, Ty. Division, P.W.D. Rishkesh, for "Construction of मा० मुख्यमंत्री घोषणा संख्या 233/2012 के अन्तर्गत जनपद देहरादून के विधान सभा क्षेत्र रायपुर के अन्तर्गत सौड़ा-द्वारा से चमेली चौक तक मार्ग का नव निर्माण कार्य (Proposed Length- 5.60K.M)" under FCA-1980 of 3.01 ha. of forest land non-forestry purpose. The Project envisages the use of, "Construction of मा० मुख्यमंत्री घोषणा संख्या 233/2012 के अन्तर्गत जनपद देहरादून के विधान सभा क्षेत्र रायपुर के अन्तर्गत सौड़ा-द्वारा से चमेली चौक तक मार्ग का नव निर्माण कार्य (Proposed Length- 5.60K.M)". The site inspection of the land involved in the proposal has done by me on dated 16-07-2015.

On inspection of the site, it is found that the land required by the user agency is a Reserve Forest + Private Forest + Civil Forest (RF 3.01 ha. + PF 0.00 ha.+CF 0.00 ha.) = 3.01 ha.

The requirement of forest land as proposed by the user agency in Col.2 part-I is unavoidable and is barest minimum required for the project.
