A proposal has been received by this office from **Sub Divisional Engineer Transmission (BSNL), Kurukshetra - 136118, Haryana** for diversion (under FCA-1980) **1.81125 ha.** of forest land for non-forestry purpose. The project envisages the use of forest land for **Laying of Optical Fibre Cable from vill. Alampur to KMCH RD, Sunheri Khalsa to KMCH RD, Amin to Amin JNT, Bir Amin to KMCH RD, Khaspur to Amin Chowk, Fatupur to Amin Chowk, Chander Bhanpur to Amin Chowk, Palwal to Sec-7 BTS, Samani to KKR-KRLRD, Jhirbari to KKR – KRLRD, Kishanpur to Umri RD, Daulatpur to Umri RD, Bodhi to Umri RSU under forest Division & Distt. Kurukshetra by the BSNL, Kurukshetra.** The site inspection of the land involved in the proposal has been done by me on dt 17.07.2015

2. On inspection of the site, it is found that the land required by the user agency is a Forest area measuring **1.81125 ha.**

3. The requirement of forest land as proposed by the user agency in Col. 2 of part-I is unavailable and is barest minimum required for the project.
