

SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF (for the forest land to be diverted under FCA)

S.1 A proposal has been received by this office from Executive Engineer TD PWD Srinagar, HQ-Kirtinagar for diversion under FCA-1980) of 1.188 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of Dadaili Bhandoli motor road from Bagwan Jamnikhal motorroad in Tehri Garhwal. The site inspection of the land involved in the proposal has been done by me on dated. 08/06/2015

S.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 1.188 ha. R/F - 0.765 C/F 0.423 Total - 1.188 Hais
