The proposal involves diversion of 4.97 ha. of Protected forest land for establishment of Battalion Camping site for the Central Reserve Police Force (CRPF) 157 Battalion, Adityapur. The proposed forest land falls in the village Dindli of Seraikela Range which lies in the Territorial Jurisdiction of Seraikela Forest Division.</p> <p>The proposed forest land is almost plain and barren without any tree species or fauna.</p> <p>The density of vegetation is about 0.05-0.1</p> <p>The proposed area is not a part of any National park or Sanctuary or established elephant corridor but, it forms a part of the Singbhum Elephant Reserve. As the Dindli protected Forest (57.42 Ha) falls within the Adityapur Industrial Area, there is a lot of pressure of encroachment on Forest Land by unscrupulous elements. The presence of CRPF camp in the area would act as a deterrent in preventing encroachment of forest land.</p> |
