

SITE INSPECTION REPORT OF DFO TERRITORIAL, EAST DIVISION GANGTOK

Site Inspection Report for proposal for the diversion of 1.39ha of Forest land for construction of landfill site for solid waste management at Bhasmay Reserve Forest in East District of Sikkim by Urban Development and Housing Department, Government of Sikkim.

1. Legal Status of Forest Land proposed for diversion:-

Bhasmey Reserve Forest.

2. Item wise break-up details of forest land proposed for diversion:-

Details:-

1. Check-post 30'x30'	=0.01ha.
2. Compost Plant 50'x50'	=0.057ha.
3. Land fill 200'x200'	=0.918ha.
4. Approach Road 200'x12'	=0.055ha.
5. Lichet Tank	=0.35ha.
Total	=1.39ha.

3. Total Cost of Project at present rates.

Rs.1.5 crore.

4. Whether forest area proposed for diversion is important from wildlife point of view:-
Does not forms the parts of any National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Corridor etc.

5. Approximate distance of proposed site for diversion from boundary of forest.
0.5Km.
