

FIELD INSPECTION NOTES OF SIVALA RAMBABU,IFS., FOREST DIVISIONAL OFFICER, ADILABAD FOR DIVERSION OF 1.701 HA OF FOREST LAND IN ADILABAD DIVISION IN FAVOUR OF SUPERINTENDING ENGINEER,TDWSP (RWS&S) CIRCLE, NIRMAL FOR LAYING OF PIPE LINE AND CONSTRUCTION OF STRUCTURE IN SEGMENT – 22/17 (POWERGUDA) FOR PROVIDING SAFE DRINKING WATER TO ADILABAD DISTRICT ON .11. 2016

I along with concerned Range staff inspected the proposed diversion of Forest Land for laying of pipe line and construction of other structures for providing safe drinking water in Adilabad dist in SEGMENT – 22/17 (POWERGUDA) in Adilabad Forest Division. The proposed area is falling in Wadgaon,Utnoor, Utnoor Ext-II & Tadihathnoor Reserve Forest Blocks. The areas diverted in Reserve Forests details are as follows:

The length of Laying of pipe line in forest is 19.38KM (19385.568 Mts) and width is 0.70 to 6.00 Mts. The proposed area passes through Southern Tropical Dry Deciduous forest with canopy density of (0.4).

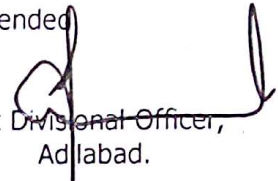
Regarding the flora present in the area, the species commonly found are *Chloroxylon swietenia* (Billudu) *Lagerstroemia parviflora* (Chennangi) *Lannea coromandelica* (Gumpena), *Tectona grandis* (Teak), *Butea monosperma* (Moduga), *Boswellia serrata* (Anduga) *Cassia fistula* (Rela) *Azadirachta indica* (Vepa), *Acacia Arabica* (Tumma), *Holoptelia integrifolia* (Nemalinara), and *Madhuca indica* (Eppa).



Regarding violations in the Forest Conservation Act, 1980, there is no violation in the proposed site of the project.

The said proposed area for diversion does not form part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant Corridor etc. There are no rare/ endangered/unique species of flora and fauna found in the forest area proposed for diversion. There are no protected Archaeological/ Heritage site/Defence establishment or any other important monument in the forest area proposed for diversion.

The laying of pipe line for drinking water will solve the acute drinking water problems in the interior tribal villages in tribal areas in Adilabad District. Hence recommended
