उक्त प्रस्तावित मार्ग 7 मीटर चौड़ाई में गठित किया गया जिसमें आरक्षित वन भूमि 5000 मीटर (3.50 है०) तथा वन पंचायत भूमि 0.28 है० प्रभावित होती हैं। आरक्षित वन भूमि में 924 वृक्ष तथा वन पंचायत में 71 वृक्ष प्रभावित होते हैं। कुल 995 वृक्षों में 0-10 व्यास श्रेणी के 449 वृक्ष तथा 10-20 व्यास श्रेणी के 372 वृक्ष समल्लित हैं। जिसमें से 0-10 तथा 10-20 व्यास सेमी० के बाँज प्रजाति के वृक्ष क्रमशः 114 तथा 87 वृक्ष प्रभावित होते हैं। उक्त 0-10 तथा 10-20 व्यास सेमी० के कुल 821 वृक्षों के प्रत्यारोपण में व्यय होने वाली धनराशि को वहन करने हेतु अधिशासी अभियन्ता अस्थाई खण्ड लो०नि०वि० द्वारा प्रमाण पत्र दिया गया है। स्थल निरीक्षण के दौरान स्थानीय जन प्रतिनिधियों द्वारा अवगत कराया गया कि उक्त मार्ग के निर्माण से ग्राम च्यूडीगाड, पुटगॉव, दूनी, बिरसिम्यौ ग्रामीणों के 1225 परिवार जिसकी जन संख्या 2266 हैं लाभान्वित होते हैं। अतः प्रस्ताव को भारत सरकार की स्वीकृति हेतु संस्तुति सहित अग्रसारित किया जाता है।
