 Condition of vegetation and type of forest in applied area

The applied area is situated adjacent to and in continuum with Karo Reserve Forest which comes under 3C/C2e(iii) Moist Peninsular Valley Sal Forest type under Champion and Seth Classification with density 0.3 and site quality-III .The prevailing vegetation consists of Sal and its associates. The principal associates of Sal includes Terminalia Lagerstroemia perviflora, Anogeissus latifolia, Terminalia belerica, Syzygium cumini, Mangifera Schleichera oleosa, cordifolia. indica. Adina Pterocarpus marsupium, Bombax ceiba, Bridelia retusa, Madhuca indica. The middle storey is represented by Syzygium cumini, Ougeinia ougenensis, arborea, Treama orientalis, Emblica officinalis, Cassia shrubs and undergrowth are Thefistula etc. pulchella, characterized  $b\nu$ Indigofera Ardisia solenacea, Flemingia chhapar, Helicteres ixora and Clerodendron viscosum etc. The prevailing climbers include Bauhinia vahlii, Combretum decandrum and Beutia parviflora. The grasses over the forest floor include Chrysopogon aciculatus, Imperata cylindrica, Dicanthium carricosum, Cynodon dactylon etc. .

10. Position of Wildlife in general

The wildlife present in the Karo R.F. are also seen in the applied area. Karo Reserved Forest is the dwelling habitat for leopard(Panthera pardus), bear(Melursus ursinus), barking dear(Muntiacus muntjack), hyena(Hyena hyena), porcupine (Hystrix indica) etc. . Frequent migration of wild elephants from the neighbouring State of Jharkhand are also noticed. This falls under elephant habitat Zone-2 as mentioned by ORSAC, Bhubaneswar. It is mentioned that Karo-Karampada Elephant Corridor passes through the mines in Karo RF over 317.0 ha. which has been considered for diversion and got diverted vide F No.8-17/1997-FC(pt) dtd.09.072013 and F No.8-17/1997-FC(pt.) dtd.12.11.2014.

Total 2957 No. of trees (Virgin-434 Nos. & broken up 2523 Nos.) and 1150 Nos. of poles (Approx.) are to be felled. The probability of soil erosion is likely to increase following felling on the undulating topography of the applied area. It is mentioned that presence of tree growth in the broken up land up to the tune of 2523 is due to afforestation measures taken up by the User Agency.

Action taken by the DFO, Keonjhar Division:-

For the illegal production of Mineral, OR case No.41BL of 2014-15 dated 11.08.2014 has been booked. Prosecution has been sanctioned against the Mines Manager and submitted in the Court of JMFC, Barbil vide PR No.24 of 2014-15 dated 26.11.2014. The case is sub-judice.

Observation of the DFO, Keonjhar Division as regards the land use in respect of the Mining Lease during 2<sup>nd</sup> RML.

The proposed land use plan submitted during submission of the diversion proposal during 2<sup>nd</sup> RML does not depict the details of land use as regards mining operation and all activities associated with mining operation has been broadly reflected as Mining. However, the detailed land use verified during the year 2014-15 depicts each item of activity associated with mining operation. The respective maps showing land use are annexed herewith as Annexure-18 and Plate No. XII with the Diversion Proposal.
