5.1 A proposal has been received by this office from **Executive Engineer Provincial Division P.W.D.Nainital** for diversion under FCA-1980) of **0.495** ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **Nainital Kaladhurgi Motor Road Km. 20 to Nalni** The site inspection of the land involved in the proposal has been done by me on dated 10-06-2016

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring **0.495 ha.** RF

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**

प्रस्तावित मार्ग नैनीताल कालादुर्गी मोटर मार्ग के किमी 0 20 से नलनी मोटर मार्ग में नैनीताल वन प्रभाग की आरक्षित भूमि 550 मीटर लम्बाई में शेष कास्तकारों की भूमि प्रभावित होती हैं जो रामनगर वन प्रभाग के अन्तर्गत हैं । प्रयोक्ता एजेन्सी द्वारा प्रस्ताव 550 मीटर लम्बाई तथा 9 मीटर चौड़ाई में गठित किये गये हैं । प्रस्तावित मार्ग के प्रस्तावित समरेखण में 9 वृक्ष आरक्षित वन भूमि में प्रभावित होते हैं । बोंज के कोई वृक्ष प्रभावित नहीं होते हैं । उक्त मार्ग के निर्माण से नलनी ग्राम की 234 जनसंख्या लाभान्वित होगी । स्थल निरीक्षण के दौरान स्थानीय जनता द्वारा अवगत किया गया कि उक्त मोटर मार्ग से ग्रामीणों को यातायात की सुविधा प्राप्त होगी । उक्त प्रस्तावित समरेखण को संस्तुति सहित भारत सरकार की स्वीकृति हेतु अग्रेषित किया जाता है ।
