A proposal has been received by this office from Executive Engineer, ग्रामीण निर्माण विभाग, देहरादून for "Construction of ग्रामीण सड़के एवं ड्रेनेज विभाग के अन्तर्गत नौ बीघा-रिखोली मुख्य मार्ग के किमी 0 16 से नारायण सिंह के घर तक ग्रामीण सड़क के निर्माण हेतु (Proposed Length- 1.430 K.M)" under FCA-1980 of 0.889 ha. of forest land non-forestry purpose. The Project envisages the use of, "Construction of ग्रामीण सड़के एवं ड्रेनेज विभाग के अन्तर्गत नौ बीघा-रिखोली मुख्य मार्ग के किमी 0 16 से नारायण सिंह के घर तक ग्रामीण सड़क के निर्माण हेतु". The site inspection of the land involved in the proposal has done by me on dated 22 - 07- 2016.

On inspection of the site, it is found that the land required by the user agency is a Reserve Forest + Prevate Forest + Civil Forest (RF 0.889 ha. + PF 0.00 ha.+CF 0.00 ha.) = 0.889 ha.

The requirement of forest land as proposed by the user agency in Col.2 part-I is unavoidable and is barest minimum required for the project.

No rare/endagered/unique species of flora and fauna is found in the area.

No protected archeological/heritage site/defense establishment or any other important monument is located in the area.
