This particular land is within the boundary of same 11 Ha. area.</p> <p>The wildlife interpretation and Nature interpretation centre will depict various wildlife Natural, Environmental processes happening of our planet.</p> <p>In this Eco-Park, Landscaping will involve planting various ornamental plants, flowering plants, medicinal plant and grasses. We hereby seek permission for these activities also. All these activities will be covered within 0.99 Ha. area only.</p>
