

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

A proposal has been received by this office from DIVISIONAL ENGINEER, TEIECOM PROJECTS, Dehradun, for "Construction of जनपद-टिहरी गढ़वाल के अन्तर्गत मसूरी वन प्रभाग के कार्यक्षेत्र नैनबाग से ऐन्दी, पत्थरखोल तक (लम्बाई- 37.300 किमी० एवं 40से०मी० चौड़ाई में) Permission for OFC laying along the road from Nainbagh Exch. to Dhararsu T-Point (via Pantwari, Aindi, Banchaura, Dharkot & Jagdai) " under FCA-1980 of 0.132 ha. of forest land non-forestry purpose. The Project envisages the use of, "Construction of जनपद-टिहरी गढ़वाल के अन्तर्गत मसूरी वन प्रभाग के कार्यक्षेत्र नैनबाग से ऐन्दी, पत्थरखोल तक (लम्बाई- 37.300 किमी० एवं 40से०मी० चौड़ाई में) Permission for OFC laying along the road from Nainbagh Exch. to Dhararsu T-Point (via Pantwari, Aindi, Banchaura, Dharkot & Jagdai) ". The site inspection of the land involved in the proposal has done by me on dated 22-12-2017.

On inspection of the site, it is found that the land required by the user agency is a Reserve Forest + Private Forest + Civil Forest (RF 0.132 ha. + PF 0.00 ha.+ CF 0.00 ha. = 0.132 ha.
