FIELD INSPECTION NOTE OF CONSERVATOR OF FORESTS, ADILABAD CIRCLE, ADILABAD FOR THE PROPOSAL OF DR. B.R. AMBEDKAR PRANAHITHA CHEVILLA SUJALA SRAVANTHI PROJECT IN BELLAMPALLY DIVISION ON 30.09.2016 and 01.10.2016.

Project Details:

I along with concerned staff have inspected the area proposed Diversion of 1081.0149 ha of forest land in Kagaznagar, Bellampally and Mancherial forest divisions for construction of Barrage at Tumidihetti village and main canal for Dr. B. R. Ambedkar Pranahitha Project in favour of Chief Engineer (Projects), Adilabad.

Scope of the scheme :

- To provide irrigation facilities for a command area of 6,63,700 ha in Drought prone areas in 7 district of Telangana state.
- To provide 10 TMC as drinking water to the enrooted villages.
- To provide 30 TMC as drinking water to twin cities of Hyderabad and secunderabad.
- To provide 16 TMC as Industrial water.

Salient features of the scheme:

➤ Diversion of water from Pranahitha River	: 20 TMC
➤ Net culturable command area	: 1,56,000 acres
➤ Barrage FRL	: +148.000 M
➤ Canal sill level	: +145.250 M
➤ Canal FSL	: +147.250 M
➤ Total length of the system	: 99.100 Km (Approx.)

The details of forest area proposed to be diverted is as follows.

The alignment of main canal passes through certain reaches of the forest and extent of forest land required and the purpose wise breakup of the total land required are as follows:

2.2 There is no work in violation of the Act has been carried out by the User Agency.

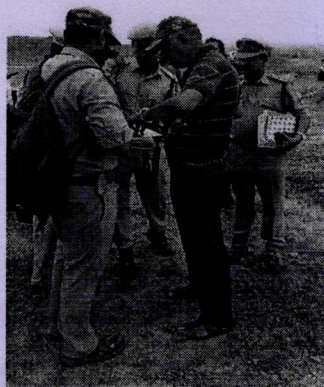


Kaghaznagar Division:-



- 1) **Bejjur Range:** The user agency has excavated the earth over an area of 16.512 Ha. without prior permission. An offence case was registered vide POR No. 23/250, dt. 17.06.2014 against the officials of Irrigation Department namely Sri K. Sudhakar Reddy, Executive Engineer, I&CADD, PP Rao Project (Dr. BRAPCSS Project) Bellampally Division and Sushee Infrastructure (P) Ltd. Hyderabad and Others. Further the Forest Range Officer, Bejjur reported that, the total excavated area is verified and ascertained to be 48.5295 Ha. No work is in progress.
- 2) **Kaghaznagar Range:** The user agency has excavated the earth over an area of 0.40 Ha. excavating the earth to an extent of 41,250 Cmt. without prior permission. An offence case was registered vide POR No. 26/37/90-91, dt. 29.11.2014 against the officials of Irrigation Department namely Sri K. Sudhakar Reddy, Executive Engineer, I&CADD, PP Rao Project (Dr. BRAPCSS Project) Bellampally Division and Sushee Infrastructure (P) Ltd. Hyderabad and Others. No work is in progress.

Mancherial Division:

The package - IV are passing through Chennur Reserved Forest. The total area proposed for diversion in Chennur Reserved Forest is 34.4167 Ha. the Package IV passing through compartment Nos.126 area 7.1063 Ha & Compt. No. 127 area 27.3104 Ha, the proposed diverted area for Package IV is 34.4167 Ha.
