

Site Inspection Report, D.C.F.

During joint inspection of proposed site on 28.01.2017 with the B.V. Subbarao, Asst. General Manager, Power Grid Corporation of India Ltd., Dhanbad it was found that total forest area is 4.1048 hectares (Notified forest- 1.8271 ha. & Jungal-Jhari- 2.2777 ha.) spread in 08 Mouzas namely Bijaybandh, Daulatpur, Tengdhowa, Ghormundi, Shukbari els Murgabani, Bando, Dandodumaria & Daldali. The area has sparse vegetation and average density of vegetation is 0.4 only. The vegetation is mixed type and consists of species namely in tree list (Palash, Neem, Bamboo, Piple, Khejur, Plam, Shirish, Dumur, Sishu, Jamun & Fire wood) and other miscellaneous species. Certain trees are very old and needed to be removed during proposed Construction of three electricity tower.

Jackal, Monkey, Hare, Roche, Python, Wild pig, Hyena, Migratory Elephants etc. are common animals to be found in and around the project area. Migratory Elephant usually move in and around the project area. Elephant has crossed through Daulatpur, Tengdhowa and Birajpur village on 24.7.2015.

Enumeration lists of trees falling within the proposed electricity tower 1.172 KM (Notified forest-0.522 km. & Jungal-Jhari-0.650 km.) alignment is submitted by B.V. Subbarao, Asst. General Manager, Power Grid Corporation of India Ltd.. It has been submitted by Range Forest Officer, Hizla West Range, Dumka vide its letter no. 51 dated 27-01-2017 inspected and verified by joint inspection team on 28.01.2017 which has been found to be correct.

The proposed three electricity tower will act as life line of Santhal Pargana Commissionery. This electricity tower will help to ameliorate the economic condition of the people of Jharkhand as a whole. Hence, this project is needed for overall development of Jharkhand state.

Joint Inspection report of 04.1048 hectares (1.172 KM) Forest land which falls within the R.O.W. of proposed Govindpur-Dumka transmission Line 220 KV D/C within Dumka Forest Division. List of tree has been submitted with proposal by the user Agency.

Joint inspection was carried out for the proposed Govindpur-Dumka Transmission line 220 KV D/C passing through spread in 08 Mouzas namely Bijaybandh, Daulatpur, Tengdhowa, Ghormundi, Shukbari els Murgabani, Bando, Dandodumaria & Daldali. The enumeration list of trees and map for felling of trees falling in the ROW and submitted by the User Agency vide his revised letter no. ER-I/JCP/Dhanbad/GDTL/Forest dated 23.01.2017 was also verified in **Sample**. Map which is attached with proposal has been found correct. Jackal, Monkey, Hare, Roche, Python, Wild pig, Hyena, Migratory Elephants etc. are common animals to be found in and around the project area. Migratory Elephant usually move in and around the project area.
