## **Site Inspection Report**

I have inspected the proposed site on 24.03.2017 for diversion of 3.50 hectares of forest land for use of approach road from mining head of M.L.No.2313 of M/s JSW Steel Ltd, Toranagallu.

The Proposed area for diversion for approach road is located in Donimalai Block Forest (Section-4 notified vide Notification No. FFD-29, FAF-84 Dated: 28.02.1985) in Sandur Taluk, Bellary District, Karnataka.

The area of diversion is revised from 5.83 hectares to 3.50 hectares after conducting a joint survey of the proposed diversion area along with Department of Mines & Geology & Revenue Department on 10.02.2017. As per the joint survey report, the details of forest land required for approach road is as follows:

- 5. And another 0.50 hectares of approach road falls with in M.L.No. 1111 of M/s. NMDC Limited (marked as H-I on the map). The user agency i.e, M/s. JSW Steel Limited is cannot be granted Forest Clearanc for this patch. As, the M/s. NMDC ltd, M.L.No.1111 has already paid NPV for this patch under Section-2(iii) of Forest (Conservation) Act, 1980 as per General approval given by the Government of India vide guidelines issued dated: 01.04.2015. However, as there is no other alternate approach road, the M/s. JSW Steel ltd may be given 'right of way' and the alignment of road inside lease area may change in future as per IBM approved mining plan of the M/s. NMDC ltd, M.L.No.1111.
- 6. Some portion of the approach road falls in within 1 Km of Parvathi & Kartikeya temple, the final decision regarding mining in this area will be subject to outcome / recommendation of the committee constituted in-compliance to the Hon'ble Supreme Court order in SLP No.20180/2010.
