The said forest land has been put under Eco value Class-I with density 0.3. The Forest comes under Open Forest Category. The major species found in the proposed project area are Shorea robusta, Dalbergia sissoo, Mangifera indica, Madhuca indica, Diospyros melanoxylon, Terminalia tomentosa, Pterocarpus marsupium, Schleicheria oleosa, Careya arborea, Butea monosperma, Terminalia belerica, Cassia siamea, Mitragyna parvifolia, Bombax ceiba, Terminalia chebula, Xylocarpa, Anogeissus latifolia & Lagerstroemia parviflora.

A proposal has been received by this office from the Executive Engineer, N.H. Division, Jeypore for diversion (under FCA-1980) of 7.743 ha. of Forest Land. The project envisages the use of forest land for Widening to two lane form 327/700 to 413/700 Km of N.H. 326 (erstwhile Km from 16/0 to 102/0 Km of SH-25) under Vijayawada-Ranchi route in Koraput and Malkangiri District of Odisha on EPC basis . The site inspection of the land involved in the proposal has been done by me on date 09.05.2017. On inspection of the site, it is found that the land required by the User Agency is a forest measuring 7.743 ha.

The requirement of forest land as proposed by the user agency in Col.2 of Part-I is unavoidable and is barest minimum required for the project. There is no non-forest land involved in the project.


