**SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF**

5.1 A proposal has been received by this office from **Executive Engineer Provincial Division P.W.D. Almora** for diversion under FCA-1980) 1.547 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **Punagarh Natalo to Sem Mandir to Nauli Motor Road** The site inspection of the land involved in the proposal has been done by me on dated **2-5-2017**

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring **1.547 ha.** village Forest /sivil soyam

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**

उक्त प्रस्तावित मार्ग 3 किमी0 लम्बाई तथा 9 मीटर चौड़ाई में गठित किया गया जिसमें वन पंचायत भूमि 896 मीटर यानि 0.806 है0 सिविल एंव सोयम भूमि 823 मीटर यानि 0.741 है0 तथा 1281 मीटर यानि 1.163 है0 नाप भूमि प्रभावित होती हैं । उक्त प्रस्तावित मार्ग 197 वृक्ष विभिन्न प्रजाति के प्रभावित होते हैं । 197 वृक्षों में से 159 वृक्ष विभिन्न प्रजाति के नाप भूमि में प्रभावित होते हैं । ऑन लाईन में वन पंचायत में प्रभावित होने वाले 29 वृक्ष का उल्लेख किया गया है जिसमें 0-10 व्यास सेमी0के 9 वृक्ष ऑन लाईन टिप्पणी में अंकित किये गये हैं । जिसमें बॉज प्रजाति के 4 वृक्ष प्रभावित होते हैं । स्थल निरीक्षण के दौरान स्थानीय जनप्रतिनिधियों द्वारा अवगत कराया गया कि उक्त मार्ग के निर्माण से ग्राम नाटाडोल ग्रामीणों के 239 परिवार जिसकी जन संख्या 1438 हैं लाभान्वित होते हैं । अतः प्रस्ताव को भारत सरकार की स्वीकृति हेतु संस्तुति सहित अग्रसारित किया जाता है ।
