5.1 A proposal has been received by this office from **Director Idea Cellular Ltd New Delhi** under FCA-1980) 1.547 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **Nainital to Ranibagh optical fiber cable laying along with road edge** The site inspection of the land involved in the proposal has been done by me on dated **8-6-2017**

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring **0.93 ha.** RF /PF

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**
