Beed Laxmangarh area 3.90 ha. and Beed Balara area 1.425 ha. having total area 9.65 ha. in Range Laxmangarh of Division Sikar in favour of Project Director-II (PPP) PWD, Rajasthan, Jaipur.

A proposal has been received by Nodal Officer (FCA) Rajasthan, Jaipur online Dated 30.06.2017 for Diversion of 9.65 ha. Forest land in Protected forest area of Forest Block Beed Bhuma Chhota area 4.325 ha. Beed Laxmangarh area 3.90 ha. and beed Balara area 1.425 ha. having total area 9.65 ha. in Range Laxmangarh of Division Sikar in favour of Project Director-II (PPP) PWD, Rajasthan, Jaipur.

The site inspection of the land involved in the proposal has been done by me on dated 22.07.2017, it is found that the land required by the user agency is a forest measuring apprx. 9.65 ha. User agency has Proposed for Construction of Road in Forest Block Beed Bhuma Chhota area 4.325 ha. Beed Laxmangarh area 3.90 ha. and Beed Balara area 1.425 ha. having total area 9.65 ha. Range Laxmangarh of Division Sikar in favour of Project Director-II (PPP) PWD, Rajasthan, Jaipur Beed Laxmangarh is declared as Procted forest Block by state Government in the year 1964 (Beed Bhuma Chhota), 1985 (Beed Balara), 1965 (Beed Laxmangarh). NH-11 is Passing through forest land of Beed Laxmangarh. Forest land of Beed Laxmangarh has already been diverted in 1500 m length, 45 m width and forest land of PF of NH- 11 in 1820 M length, 45 M Width forest land by MOEF Government of India, New Delhi by F No. 8-19/2013/FC dt.18-11-2013 by first stage diversion Clearance in Sikar-Bikaner Diversion Proposal. This Proposed road will pass through Forest land of Beed Laxmangarh in 1500 m length, 45 m width and PF of NH- 11 in 1820 M length, 45 M Width total approx. length 3320 rmt. This already diverted area of NH-11 in 3320 M length, is not included in this Diversion Proposal. In this regard, user agency has submitted Undertaking that they will not work from design Chainage km. 172.18 to Design Chainage 175.5 km because it is part of National Highway NH-11.

The requirement of forest land as proposed by the user agency in Col..2 of part- I is unavoidable and is barest minimum required for the project.

Rare/ endangered/ of flora and fauna are not found in the area in the proposed area.

There is no Game Sanctuary in these areas only Bluebulls are found in these three forest Blocks.

Any protected archaeological / heritage site / defence establishment or any other important monument is not loacated in the proposed diversion of **9.65 ha.** of Protected Forest land of Forest Block Beed Bhuma Chhota area 4.325 ha. Beed Laxmangarh area 3.90 ha. and Beed Balara area 1.425 ha.having total area 9.65 ha. in Range Laxmangarh of Division Sikar in favour of Project Director-II (PPP) PWD, Rajasthan, Jaipur

(a) The user agency Presently has not voilated the provisions of forest (Conservation) Act, 1980 and no work of Construction of Road has been started without proper sanction.

This Proposal is proposed for Diversion of forest land of forest Block Beed Bhuma Chhota area 4.325 ha. Beed Laxmangarh area 3.90 ha. and Balara area 1.425 ha. having total area 9.65 ha. in Range Laxmangarh of Division Sikar.
