
**SITE INSPECTION REPORT-NOT BELOW THE RANK OF DCF
(For the forest land to be diverted under FCA)**

- 5.1 A Proposal has been received by this office from NATIONAL HIGHWAYS INFRASTRUCTURE DEVELOPMENT CORPORATION LIMITED for diversion under FCA-(1980) of 25.825 ha. of forest land for non-forestry purpose. The project envisages the use of forest land of construction of x TUNNEL AT SILKYARA BAND FORM KM. 24.300 TO KM.51.900 ON NH-134 (DHARASU YAMUNOTRI ROAD) OF DISTRICT UTTARKASHI. The site inspection of the land involved in the proposal has been done by me check the entries before forwarding. dated 11/07/2017.
- 5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 11.083 ha. KHURMOLA-R.F.COMPARTMENT No-4,5,6A,6B,8A. IN UTTARKASHI FOREST DIVISION.
