The project envisages the use of forest land for construction of जनपद टिहरी गढवाल के विधान सभा क्षेत्र धनौली में राज्य योजना के अन्तर्गत ठांगधार-थौलधार मोटर मार्ग का नव निर्माण. The site inspection of the land involved in the proposal has done by me on date:- 09-08-2017
