Sub: TSFD - FC Act, 1980 – Proposal for diversion of 0.3927 Ha of Forest land in Yadadri Bhuvanagiri District for formation of Right of way to reach the agriculture land situated at Somajipally village in favour of M/s Padminee Plantations, Pvt. Ltd., Secunderabad – Alternate way examined - Application rejected – Report submitted - Reg.

With reference to the above, this is to submit that in the reference 1st cited, the proposals for diversion of 0.3927 Ha of Forest land in Somajipally RF of Yadadri Range of Yadadri Bhongiri District for formation of Right of way to reach the agriculture land situated at Somajipally village in favour of M/s Padminee Plantations, Pvt. Ltd., Secunderabad forwarded. It was requested to inspect the Forest area proposed for diversion, examine the factual details and feasibility of the proposals, certify the authenticated maps, carry out site inspection and enumeration of trees, inspecting adjoining flora and fauna impact of diversion on flora & fauna and mitigative measures etc., and submit the proposal duly filled in part-II along with the required information in six sets as per the instructions issued in the reference 1st cited.

In this regard, it is submitted that the Somajipally forest Block and patta land of applicant inspected personally by the under signed along with the Forest Range Officer, Yadagirigutta, Forest Section Officer, Turkapally and Forest Beat Officer Turkapally on 05.09.2017 to explore feasibility of alternate way to reach the field of the applicant to avoid fragmentation of Forest Block which is very small in extent of area 24.76 Ha only.

During the perambulation of the areas it is observed that the said patta land of the user agency is surrounded by other patta lands with orchards in the North and in the South side surrounded by water pond and West side Somajipally R.F Block. It is found that a clear way from Somajipally Village to Patta lands in the East side and West side of the user agency land and the same is also found in the Revenue village map. (Village map showing location of road is enclosed).

Therefore, it is submitted that the proposed right of way to the patta land of the applicant through Somajipally R.F is not essential and is avoidable keeping in view of fragmentation of the Forest Block very small in extent and there will be adverse effect on the Forest area if diverted for non-forestry purpose.

In view of the above, the application should be rejected and the user agency may be informed accordingly.



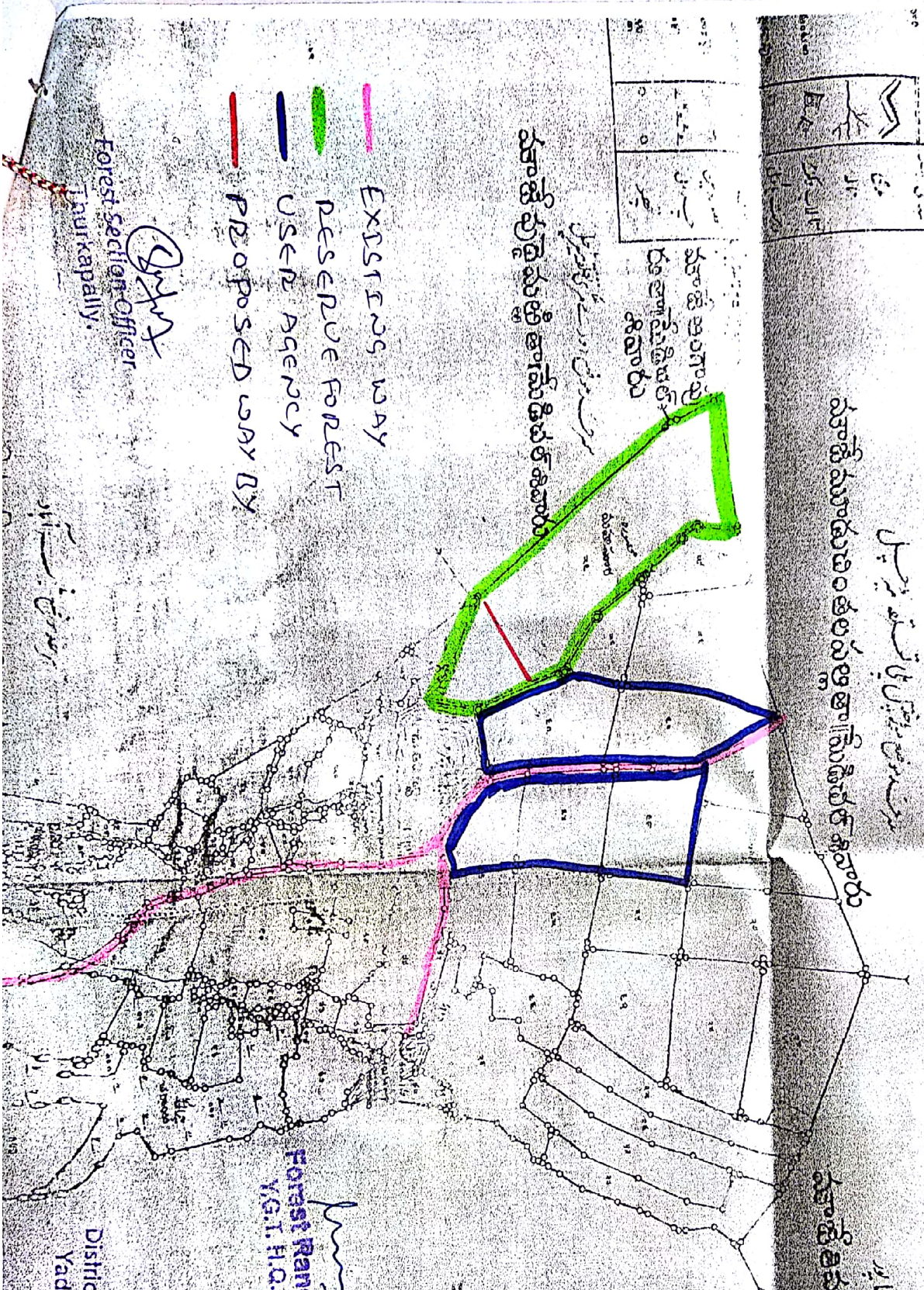
