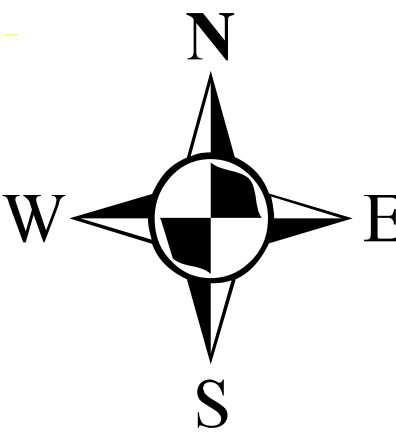


Map of Land For Compensatory Afforestation under Forest (Conservation) Act,1980

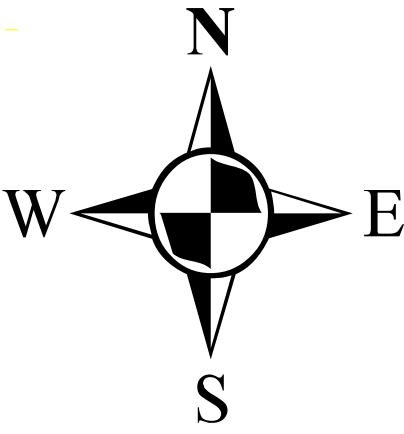

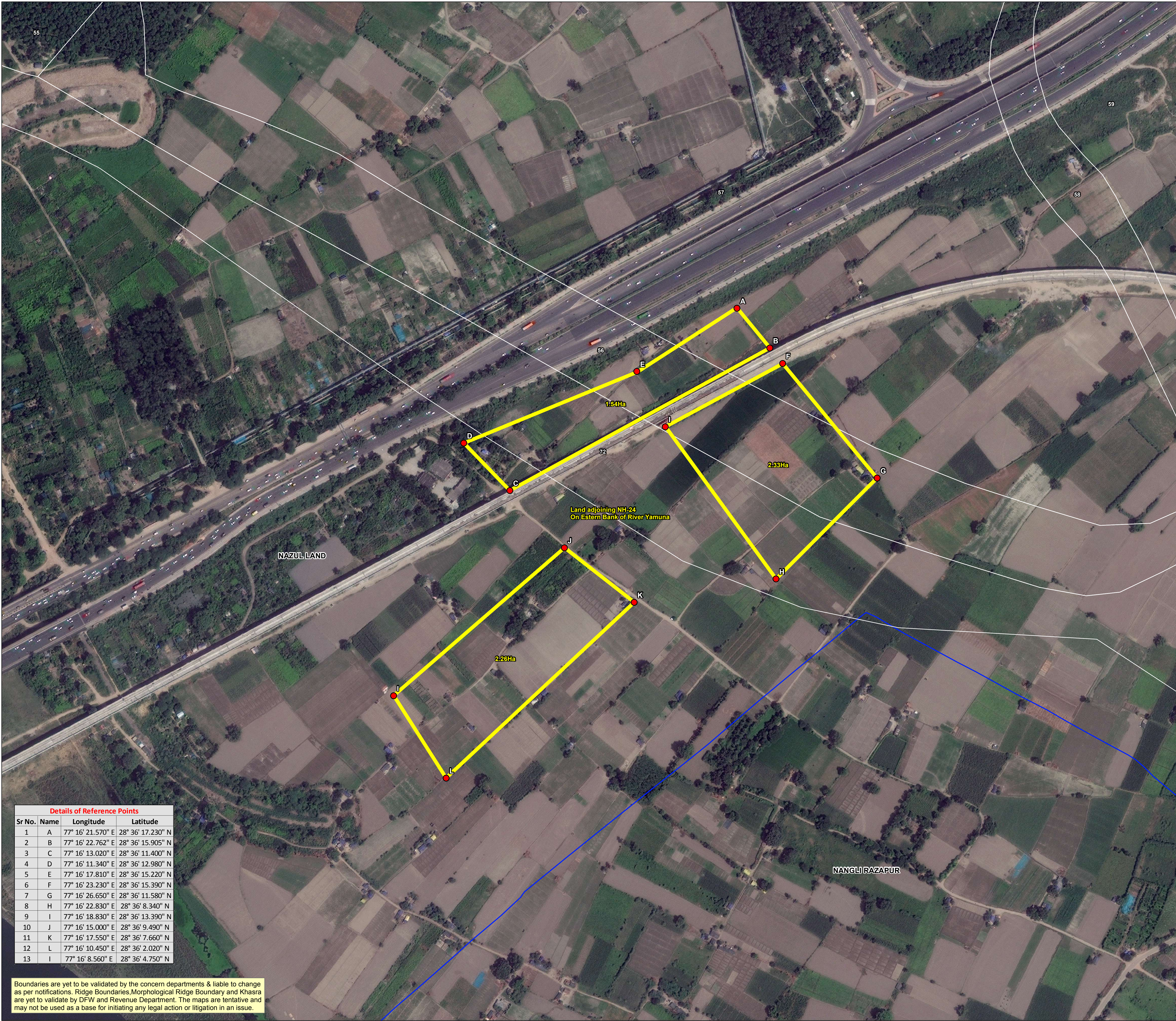
