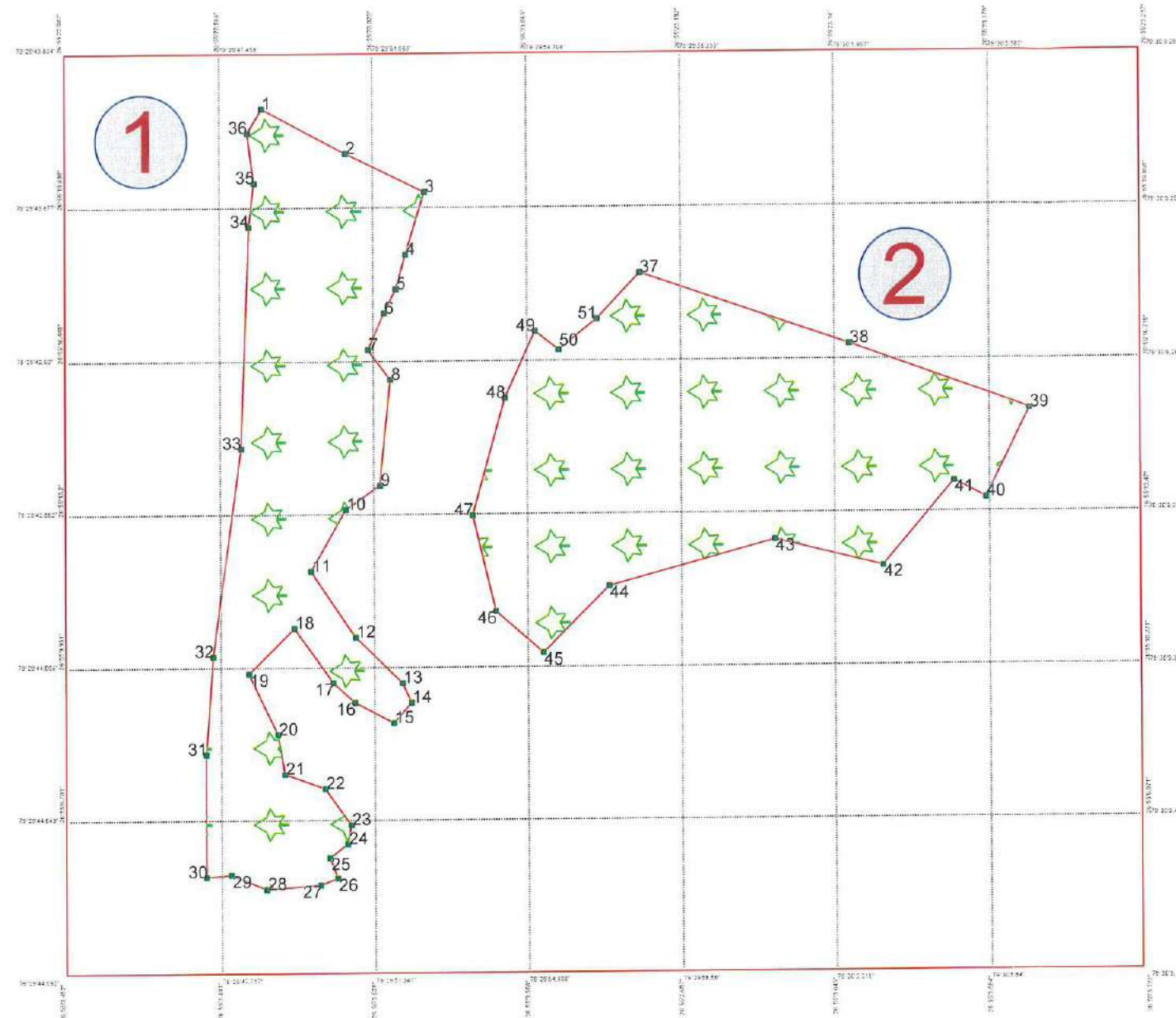

"Construction of Aligarh to Kanpur Section of NH-91 km 289.000 to km 356.000 in the state of Uttarpradesh"**



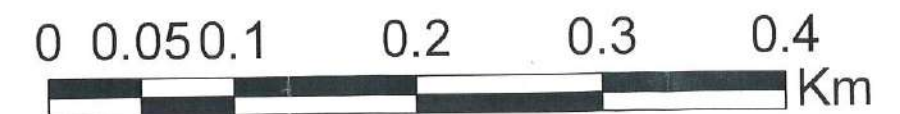
