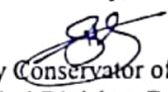

LAND IN RESPECT OF M/s. KIOCL LIMITED, BANGALORE OVER AN EXTENT OF 300.00 Ha.**

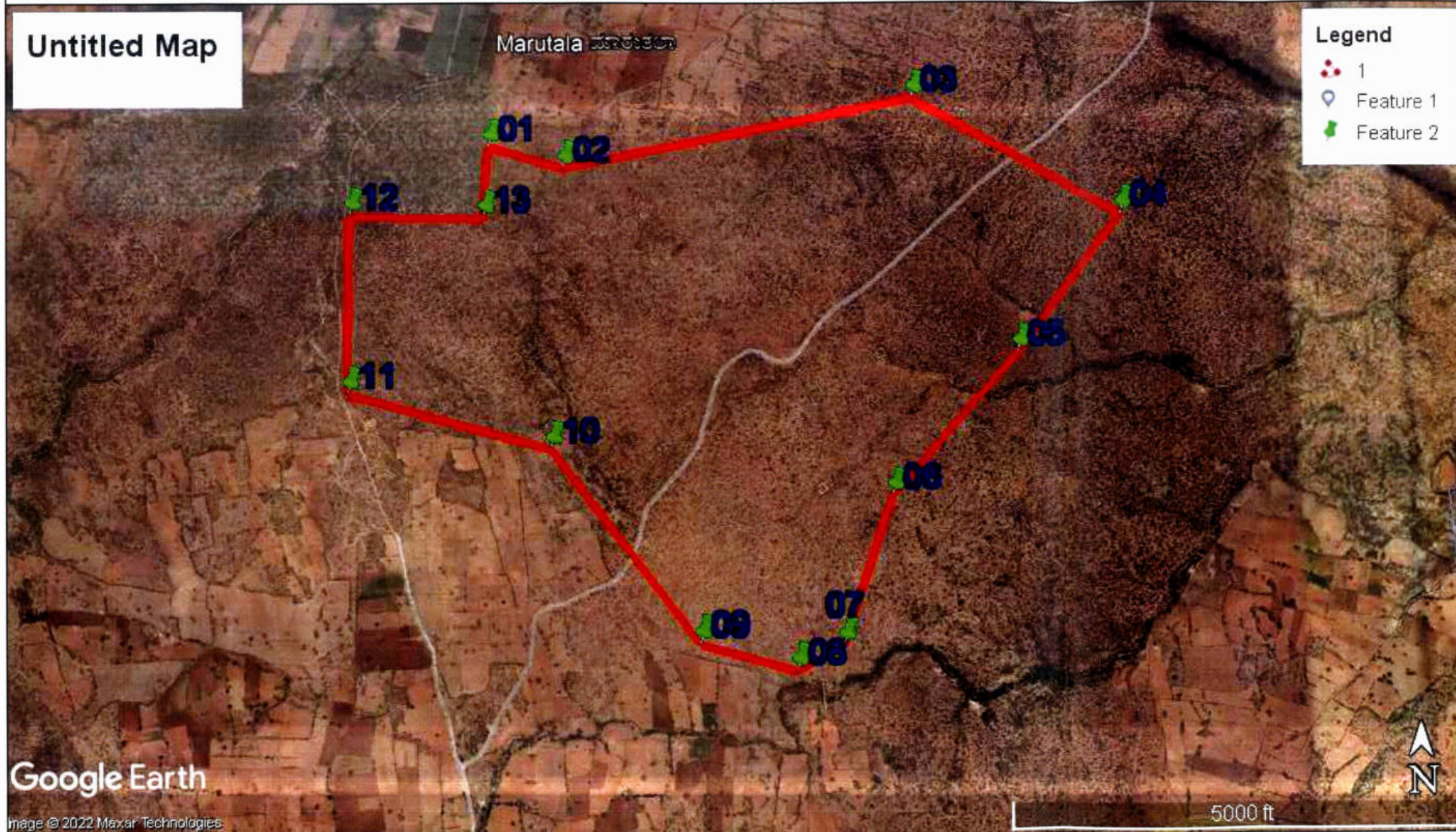

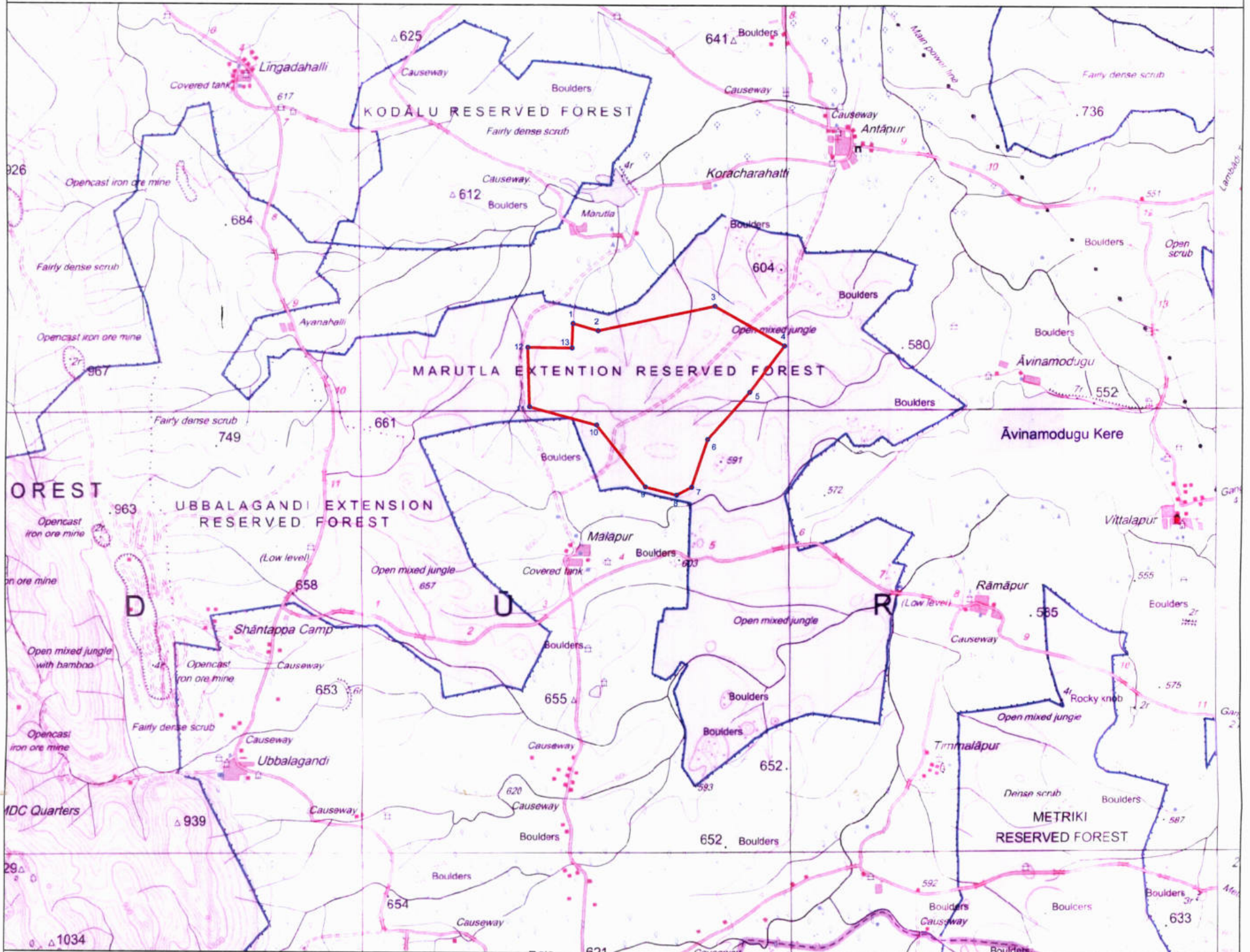

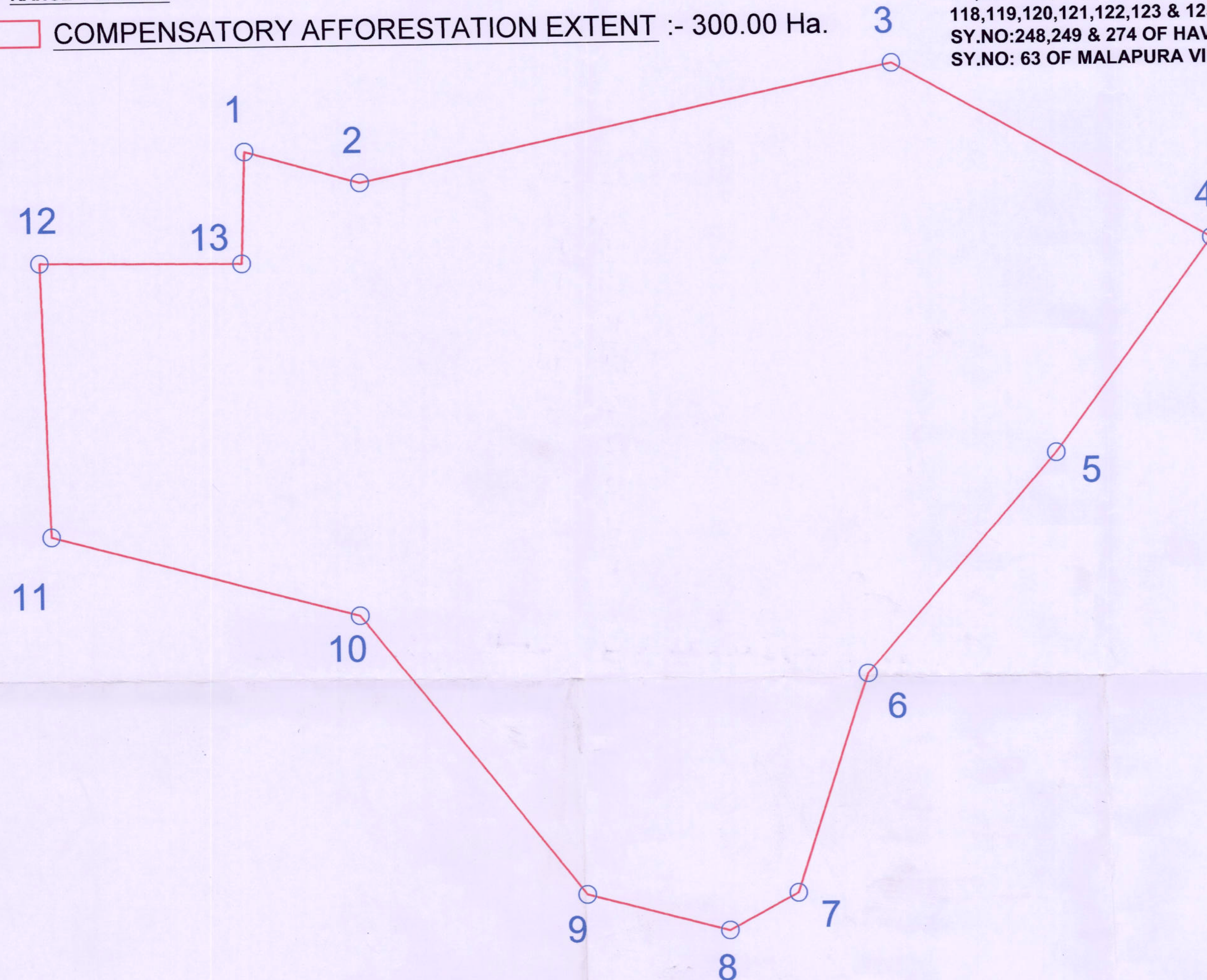
