**ORDERS BY THE GOVERNOR
NOTIFICATION**

Dated Dispur, the 6th April, 2022

No. FRM.14/2021/288 : In exercise of the powers conferred under Section 5 of the Assam Forest Regulation Act 1891, the Governor of Assam is pleased to declare its intention to constitute the land described in the Schedules annexed hereto as Reserve Forest.

The Governor of Assam, further hereby appoints the Deputy Commissioner of Biswanath District to act as Forest Settlement Officer to inquire into and determine the existence, nature and extent of rights of any person in or over the land comprised within the limits described in the Schedule below, and any claim relation to the practice withing such limits of "Jhum" cultivation and to deal with the same as provided in Chapter-II of Assam Forest Regulation Act 1891.

Under the provisions of Section 5 (2) of the aforesaid Act, the Governor of Assam appoints the Divisional Forest Officer, Sonitpur East Division, to assist the Forest Settlement Officer, in the inquiries prescribed in Chapter II in connection with the proposed reservation.

Under the provisions of Section 15, the Governor of Assam appoints the Director of Land Record, Assam to hear appeal on the orders of the Forest Settlement Officer
