ORDER:-

Through the reference 1st cited, the Secretary to Government, PR & RD has informed that they require a total of about 100.00 Ha of land for CA scheme and they came to known that sufficient land is available in Girgaon village of Tamsi mandal of Adilabad District and requested to allocate the land immediately and give the required map for DGPS Survey.

Vide reference 4th cited, the District Forest Officer, Adilabad has submitted that he has inspected the land situated at Girgaon village of Tamsi mandal on 27.02.2021, and reported that the proposed land is found suitable for compensatory afforestation purpose and can be developed into dense forest by erecting suitable protection structures, taking up soil moisture conservation measures and by taking up planting.

In the reference 5th cited, the Engineer in Chief, Panchayath Raj, Hyderabad has requested to allot the Govt. land to an extent of 87.70 Hectares in Sy.No.86 situated at Girgaon village of Tamsi Mandal to PR Department for PMGSY projects towards CA land for obtaining forest clearances to take up the Road & Bridge works in forest area across the state which include the projects sanctioned in Adilabad District.

In the reference 6th cited, the RDO, Adilabad has submitted that, the Tahsildar, Tamsi has reported that, revenue and forest officials have identified Ac.146.38 gts. of Govt.land in Sy.No.86 situated at Girgaon village of Tamsi mandal which is suitable for CA purpose and further submitted that total available Govt. land in Sy.No.86 is Ac.352.02 gts. Out of which earlier 183.00 acres of Govt. land has already proposed for Mission Bhagiratha projects for CA purpose and now out of Ac.169.02 gts. balance, land to an extent of Ac.146.38 gts. of Govt.land identified and proposed for allotment to Panchayath Raj Department for CA purpose in lieu of forest land utilized for implementation of PMGSY-I,II,III project.The RDO, Adilabad has submitted the location map, Khasra pahani, pahani for the year 2019-20.

Accordingly, vide reference 7th cited, while issuing the advance possession order, the Tahsildar, Tamsi was directed to hand over the identified land to an extent of Ac.146.38 gts. in Sy.No.86 situated at Girgaon village of Tamsi mandal to the District PR Engineer, Adilabad towards CA land for obtaining forest clearance to take up the Road & Bridge works in forest area for PMGSY projects across the state which includes the projects in Adilabad District under cover of panchanama, Zimmapatrak and also requested to incorporate in connected records of the above lands and report compliance.

Further, vide reference 13th cited, the District Panchayati Raj Engineer, Adilabad has submitted that, the Principal Chief Conservator of Forests, Hyderabad has requested the Panchayat Raj Engineering department, Telangana to obtain an undertaking from the District Collector as that, the CA land now allotted shall not be assigned for any other purpose and shall be mutated in favour of Forest Department upon receipt of in-principle (Stage-I) approval and free from all encumbrances. Further, the District Panchayati Raj Engineer, Adilabad has requested to issue undertaking and Non-encumbrances certificate for CA land to an extent of Ac.146.38 gts. in Sy.No.86 situated at Girgaon village of Tamsi Mandal. Accordingly, vide reference 14th cited, the undertaking and non – encumbrance certificate ware issued to forest department.

Further, vide reference 15th cited, the Tahsildar, Tamsi was requested to incorporate the said lands in connected revenue records entered into P.O.B. of Tahsil Office duly affecting corrections in cadastral maps, Pahanies etc., and furnish

a copy of Mutation Proceeding, panchanama & Zimmapatraka. Accordingly, vide reference 16th cited, the Tahsildar, Tamsi has submitted that, the identified land to an extent of Ac.146.38 gts in Sy.No.86 situated at Girgaon village of Tamsi Mandal has been handed over to forest officials under cover of panchanama & Zimmapatraka.

Further, vide reference 17th cited, the Engineer-in-Chief,PR PMGSY, TS, Hyderabad has requested to mutate the allotted land in Sy.No.86 to an extent of Ac.146.38 gts situated at Girgaon village of Tamsi Mandal in favour of District Forest Officer, Adilabad at the earliest, so as to accord the Forest clearances by the Forest Department to facilitate the construction of Panchayat Raj(PMGSY) roads.

In view of the above, the land bearing Sy.No.86 to an extent of Ac.146.38 gts situated at Girgaon village of Tamsi, Mandal is hereby mutated in favour of District Forest Officer, Adilabad with immediate effect.
