ORDER:

Through ref. 10th cited, the Engineer – in – Chief, PR PMGSY, TS, Hyderabad has requested to mutate the allotted land to an extent of Ac 80.01 gts situated at Demikalan (V) of Tadwai (M) in favour of District Forest Officer, Kamareddy at the earliest to accord the Forest clearances by the Forest Department to facilitate the construction of Panchayat Raj (PMGSY) roads which is identified by the Dist. Collector, Kamareddy as per the instructions of the Chief Secretary, Government of Telanagana.

Further, the ref 11th cited, the Tahsildar, Tadwai has submitted their report in the above matter and stating that he proceeded along with the Dist. Panchayath Raj Engineer, (PIU), Kamareddy, Forest Range Officer, yellareddy Asst. Engineer (PR).MRI, Tadwai and others visited the above said land and the same land is handed over to the forest Range Officer, yellareddy as per the rules in vogue.

Further, the Tahsildar, Tadwai has stated that as per online dharani the Sy.No. 419/a, Ext: Ac 206.110 gts is recorded as Govt. Notional Khatha No. 20000101 and requested to transfer to an extent of Ac 80.02 gts of land from Govt Notional Khatha (20000101) to Forest Notional Khatha No. (20000401).
