As per the executive instructions of the R & D.M. Deptt. Communicated by the Addl. Chief Secretary to Govt., vide his letter no.22958/R&DM dt. 04.08.2014 & No. 31312/R&DM dt. 24.10.2014 that non-forest Government land can be transferred for the purpose of compensatory afforestation in lieu of forest land required for development purposes. Since the proposed alienation in favour of the Forest Environment & Climate Change Deptt for a linear project i.e improvement of road from Kharabhuin PWD road Chhak to Khandahata P.S. road. it is not objectionable.

As per Notification No. 46106 dt. 04/12/2013 of the R & D.M Deptt. Odisha, & Rule 15-A of the OGLS (Amendment) Rules, 2013, the Collector has full power for sanction of alienation in favour of linear Projects. Since the proposed alienation is in favour of Forest, Environment & Climate Change Department, Government of Odisha, premium is not chargeable.
