Now therefore, the Governor of Punjab in exercise of the powers conferred by Section 30 of the said act is pleased: -

- a) To declare all trees standing in or upon these lands to be reserved from the date of publication of this notification and
- b) To prohibit from the same date the quarrying of stones/sand or burning of lime or Charcoal or the collection or subjection to any manufacturing process or removal of any forest produce in any such forest, and the breaking up or clearing of land for cultivation, for building, for herding cattle or for any other purpose, of any land in any such forests.

Whereas by this notification land mentioned in Schedule in the said notification has already been declared as "Protected Forest" under Section 29 of Indian Forest Act, 1927. Now therefore, in exercise of the powers conferred by Section 32 and 33 of the said Act, the Governor of Punjab is pleased to make the following rules applicable to all areas comprised in the aforesaid notification: -

RULES

1. No person shall:-
 - a. cut, fell girdle, lop tap any tree, strips of the bark or leaves from, purpose what-so-ever or remove any forest produce without the prior permission of the Divisional Forest Officer, Pathankot Forest Division.
 - b. Herd, pasture, graze or retain any cattle on the said land.
 - c. Cut or remove the grass, kahi, kana without the prior permission of the Divisional Forest Officer, Pathankot Forest Division. The grass will be cut above ground level with sickle only.
 - d. Clear or break up land for cultivation or for other purpose.
 - e. Set fire to grass, trees, timber or Kindle a fire on the land.

- f. Hunt, shoot, fishing, poison water and set traps on the said land.
2. The income from compounding of offences against the rule under section 68 of the Indian Forest Act, 1927, shall be credit to the Government.
