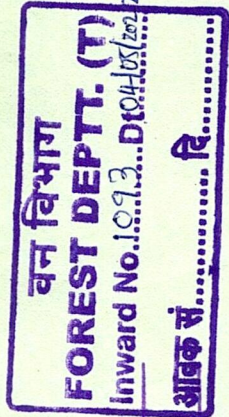
ORDER

1. The Assistant Conservator of Forests (HQ) has requested to provide the land for Compensatory Afforestation in lieu of road widening proposal from Khamel to Dudhani and from Khamel to Kherdi for diversion of Protected Forest (PF) land area admeasuring 17.82 HA and 7.70 HA, respectively vide letter referred at preamble (1). The land to be given in exchange has been identified at village Morkhal. The same has to be handed over to Forest Department against the land which is being used for road winding.
2. As laid down under Section-21 of the Dadra and Nagar Haveli Land Revenue Administration Regulation, 1971 and with the general order of the Hon'ble Administrator, DD & DNH, the Government land as per details cited below is hereby assigned to the Forest Department.

- (2) The land shall not be used for any other purpose without prior sanction of the Competent Authority.
- (3) The Survey & Settlement Officer, Dadra and Nagar Haveli, Silvassa shall hand over the physical possession of the assigned land to the Chief Conservator of Forest, DNH, Silvassa, and receipt shall be obtained to that effect may be forwarded to this office for records.
