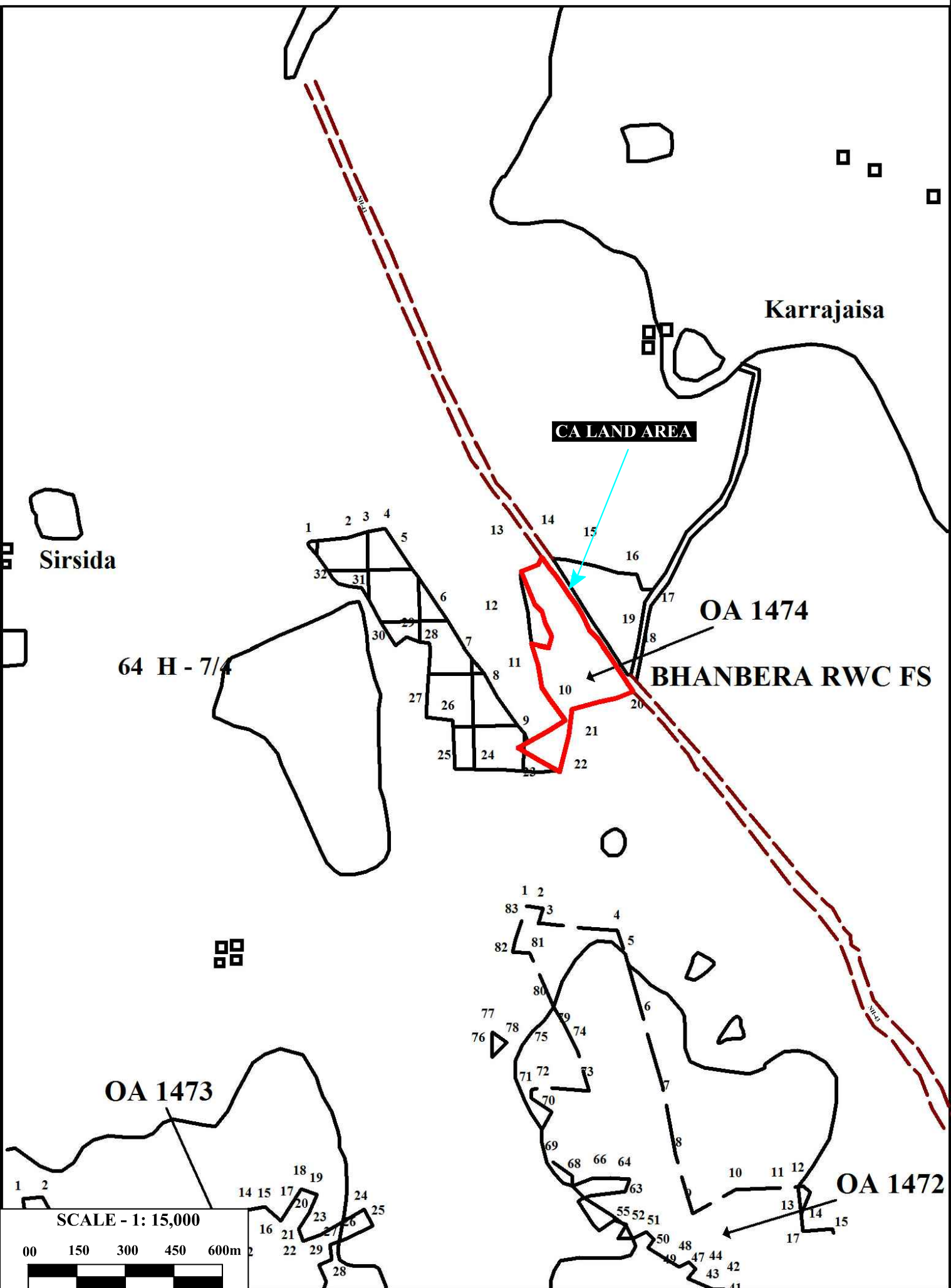
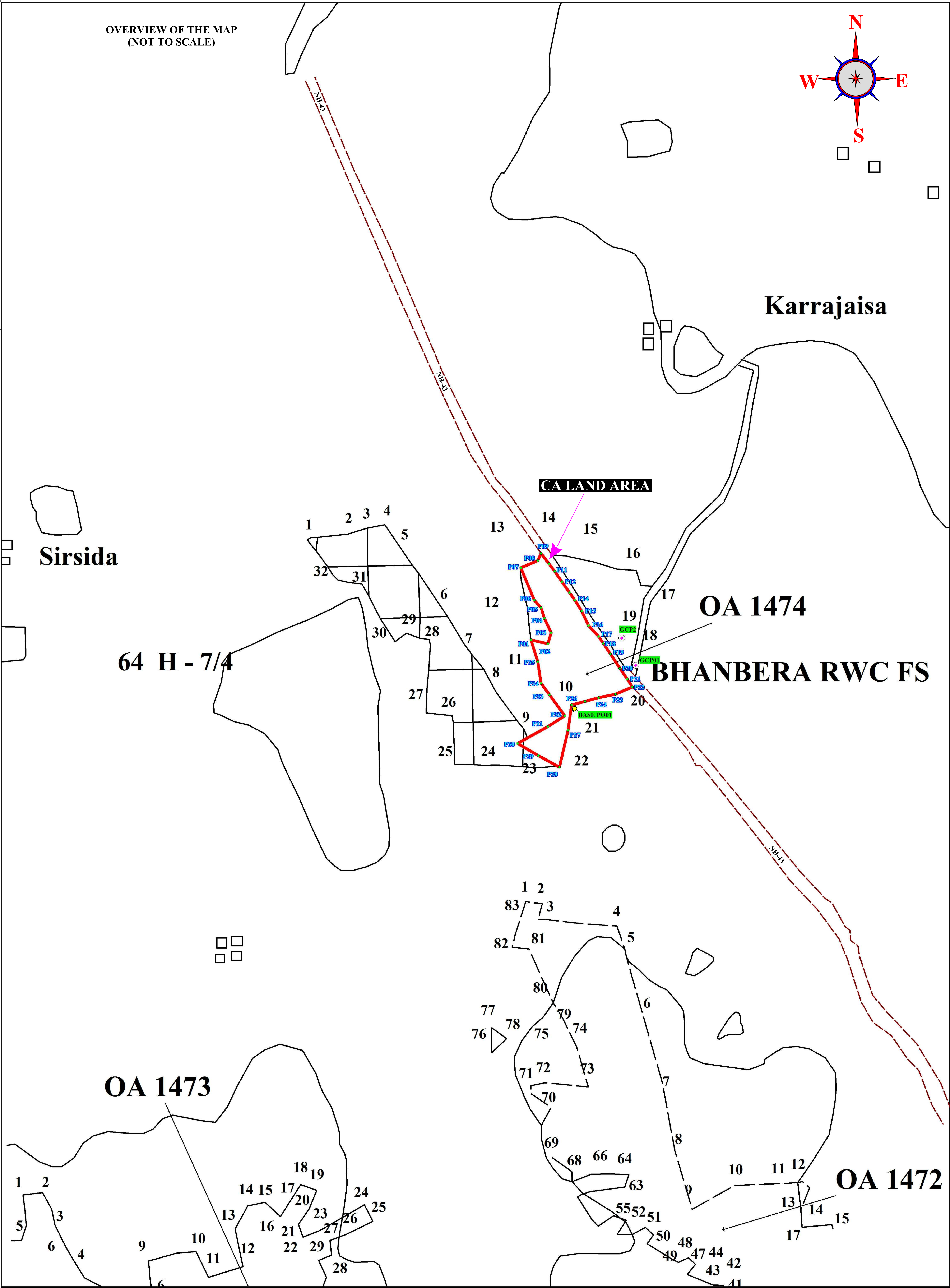


GEO REFERENCED FOREST MAP OF SIRSIDA COMPENSATORY AFFORESTATION AREA WITH FIXED BOUNDARY

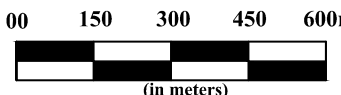
