1. The Divisional Forest Officer, Rayagada shall have only Surface right over the land.
2. The land shall be utilized for the purpose for which the lease is sanctioned and shall not be transferred or sub-leased/sub-let to any person/ organization or otherwise disposed of without prior permission of Revenue and Disaster Management Department.
3. If the land and any part thereof is not be utilized by Divisional Forest Officer, Rayagada for the purpose for which it has been leased, the same shall be revert back to Government in Revenue and Disaster Management Department free from all encumbrances.
4. The land allotted should be kept free from encroachment.
5. Infringement of any of the condition shall result immediate reversion of the land to Government in Revenue and Disaster Management Department free from all encumbrances without payment of any compensation for the structure if any, improvement that might have made to therein.

Stage-I/in-Principle approval order no.5-ORB601/2023-BHU dated 21.12.2023 of the Government of India, MoEF & C.C., Regional Office, Bhubaneswar and memo no- 26830 dt.30.12.2023 of the OSD-cum-Special Secretary to Govt., FE & CC Department, Govt. of Odisha.

In inviting a kind reference to the above-cited correspondence on the captioned subject, it is to inform you that, in compliance with the Condition No.A(ii) stipulated by the Ministry of Environment, Forest and Climate Change (MoEF&CC), Government of India, Regional Office, Bhubaneswar, while according Stage-I (In-Principle) approval vide their order no.5-ORB601/2023-BHU dated 21.12.2023, the non-forest land measuring 1.416 hectares identified for Compensatory Afforestation in village Rukunibori under Muniguda Tahasil of Rayagada district has been mutated in favour of the Forest Department in lieu of the forest land diverted for the said project.

Accordingly, the Tahasildar, Muniguda has issued the Record of Rights (RoR), map, and boundary description of the said non-forest land vide his letter No.896 dated 25.03.2026.

In compliance with the above-stated condition, the draft notification along with the Record of Rights (RoR), land schedule, map with boundary description and the alienation order No. 2764 dated 25.10.2025 issued by the Collector, Rayagada in respect of the above-identified non-forest land mutated in favour of the Forest Department are submitted herewith in quadruplicate for issuance of notification under Section 33 of the Odisha Forest Act, 1972 for declaration as Protected Forest.

ORDER

In pursuance of Order dated 13.06.2025 of the then Collector, Rayagada in Alienation/Lease Case Record No. 06/2024 and in exercise of the power conferred by Government of Orissa in Revenue & Disaster Management Department, vide their Notification No. 42899 dated 07.11.2009, Post facto approval is accorded for sanction of lease of non forest Govt. land to an extent of Ac. 3.50 (1.416 ha.) covered under Abada Ajogya Anabadi Khata, vide Khata No. 10 of village Rukunibori under Muniguda Tahasil as detailed below, in favour of State Forest Dept., in lieu of forest diversion proposal for construction of Y-Connection Railway line by M/s Vedanta Limited, Lanjigarh. The User Agency has to pay an amount of ₹.2,93,694.00 (Rupees two lakh ninety three thousand six hundred ninety four) only before the Tahasildar, Muniguda, as demand raised by the Collector, Rayagada. The above sanction is accorded with the following Terms and Conditions.

TERMS AND CONDITIONS:

1. The land shall be utilized for the purpose for which the lease is sanctioned and shall not be transferred or sub-leased / sub let to any person/ organization or otherwise disposed of without the prior permission of Revenue & Disaster Management Dept.
2. If the land or any portion thereof is not utilized, the same shall reverted to Govt. in Revenue & Disaster Management Dept. free from all encumbrances.
3. The Forest Dept. shall take such precautionary measures as necessary to keep the land free from encroachment.
4. If the land or any portion of it is not utilized within three years from the date of sanction for the purpose for which it is sanctioned, the same shall reverted to Govt. in Revenue & Disaster Management Dept. free from all encumbrances and without payment of compensation for the land or for any improvement that might have been carried out on the land.
5. Infringement of any of the conditions, shall result in immediate reversion of the land to Govt., Revenue & Disaster Management Dept. free from all encumbrances.
