Principal Chief Conservator of Forests Letter no KFD/HOFF/A5(3) GFLCR-28/2009-10- dated 19-04-2021 has revised the compensatory afforestation Rates for the year 2021-2022. In ref (5) Principal Chief Conservator of Forests (Forest Conservation) and Nodal Officer (FCA) has directed that user agency has already paid total amount of Rs. 88,55,681/-, hence issue revised demand notice to user agency. 
