With reference to the above subject, I am directed to forward herewith the proposal received by the Principal Chief Conservator of Forests,(HoFF) Bengaluru vide their letter dated:27-09-2017 referred above regarding Diversion of 0.994 (0.8093) ha. of Paisari land (forest land) in Sy.No. 1/9p2 of Kumaralli village, Madikeri Division for implementation of Beedalli Mini Hydel Project of 3 MW capacity in Somwarpet Taluk, Kodagu District in favour of M/s Kodagu Hydel Projects Pvt. Ltd. The proforma (part-V) of the State Government and conditions stipulated by the PCCF in Annexure - A is enclosed herewith.

It is to be noted that the User Agency has applied for the diversion of forest land which is very less than the 1 ha. which avoids CA land & CA. The sub-mergence of the forest land likely to happen by the check dam constructed is not noted. Production of FRA certificate in Form 2 issued from the Deputy Commissioner is Mandatory. In view of the conditions it is requested to kindly look into the matter under section 2 of the Forest Conservation Act, 1980. as deemed fit. The action taken may kindly be conveyed at the earliest.
