

1	The land under project will be reclaimed by the User Agency for which the agency shall submit a bank guarantee at the rate of Rs. 50/- per running meter and an undertaking to that effect shall also be submitted. if the agency fails to reclaim the land to the satisfaction of Deputy Conservator of Forest concerned, the cost for reclamation will be covered from the bank guarantee.	(4)	User agency should submit Bank guarantee of 1120 Rmt x Rs. 50 per Rmt = 56,000 (Rs. Fifty six thousand only) and also submit undertaking for reclamation & if the agency fails to reclaim the land to the satisfaction of Deputy Conservator of Forest concerned, the cost for reclamation will be covered from the bank guarantee.

2	If the cable is going to be laid in the formation width of the road, then additional charges in form of bank guarantee shall be given at the rate of Rs. 35/- per running meter. Similarly for reclamation of side drain and for tarred portion, the guarantee will be at the rate of Rs. 300/- per meter and Rs. 750/- per meter respectively.	(5)	As laying work of OFC will be laid within side drain of road, User agency should submit Bank guarantee of 1120 Rmt x Rs. 300 per Rmt = 336000 (Rs. Three lakhs thirty six thousand only), and also submit undertaking for reclamation & if the agency fails to reclaim the land to the satisfaction of Deputy Conservator of Forest concerned, the cost for reclamation will be covered from the bank guarantee.
