This is a Proposal for diversion of 0.0144 hectares of Forest Land under Jalpaiguri Forest Division in favour of the Reliance Jio Infocomm Limited for Setting Up e-Node B (Mobile Tower) Tower at Hillajhora Compartment.

The proposal has been recommended by the Divisional Forest Officer, Jalpaiguri Forest Division and the Chief Conservator of Forest, Northern Circle, West Bengal.

Therefore, the proposal for diversion of 0.0144 hectares in favour of Reliance Jio Infocomm Limited is recommended for 30 years for Setting Up e-Node B (Mobile Tower) Tower, subject to FRA Certificate from District Magistrate Jalpaiguri being furnished. There is no tree felling involved. The proposed site falls within the Notified Eco-Sensitive Zone of the Chapramari Wildlife Sanctuary and requires prior approval of the Principal Chief Conservator of Forests, Wildlife & Chief Wildlife Warden, W.B.
